3.	Photographer represents and warrants to Brokerage/Agent that it owns all right, title and interest in and to the Images, including copyright, is capable of assigning said rights in the Images as set forth in this Agreement, and has full right and power to enter into this Agreement.	
4.	Photographer acknowledges and understands that it is in no way permitted to use the Images in any manner whatsoever, and no other royalty or other consideration will be due to Photographer. Photographer agrees and warrants that Brokerage/Agent is under no obligation to credit Photographer or any other third party as the author of the Images.	
5.	Photographer understands and agrees that it is an independent contractor of Brokerage/Agent and nothing in this Agreement shall be construed to create a partnership, or joint venture, between Photographer and Brokerage/Agent.	
6.	The validity, construction and enforceability of this Agreement shall be governed in all respects by the laws of the State of New York. The terms and conditions set forth herein constitute the entire agreement between the parties and shall supersede all prior agreements. This Agreement may not be amended except in writing signed by the respective parties. The failure of either party to enforce its rights under this Agreement at any time for any period shall not be construed as a waiver of such rights.
